Dear Mr. Mulhall:

This Department has reviewed your request for approval of Polylok's new PL-250 six-inch effluent filter. The *Technical Standards for Subsurface Sewage Disposal Systems* (Technical Standards) stipulates new septic tanks must be installed with an effluent filter that is approved by this Department. Approved effluent filters are listed in Appendix B of the Technical Standards. Your submission included technical drawings, specifications, and product literature for the PL-250 filter, and the information indicated that the filter is rated for a design flow up to 3,000 gallons per day.

The information submitted satisfactorily documents the Polylok PL-250 filter meets the minimum requirements in the Technical Standards. This Department hereby APPROVES the Polylok PL-250 effluent filter. Attached is an updated Appendix B that includes the approved Polylok PL-250 effluent filter.

This approval will be sent electronically to local health officials, professional engineers, and to our Code Advisory Committee. This approval will also be posted on this Department's website. This letter may be reproduced as a means of notifying other parties of this Department's approval. As with all product approvals, this Department's approval should not be considered an endorsement of the product.
