

The following is an article by Andrew England about a product his company has recently introduced to the wastewater industry. Andrew is one of our newest members.

The Mantis Geotextile Sand Filter Written by Andrew England

Eljen Corporation of East Hartford, CT, has introduced the Mantis Geotextile Sand Filter. Approved by the State of Connecticut Department of Public Health (DPH) since August 2006 for subsurface wastewater disposal, the Mantis system has enabled engineers and contractors to design and install a cost effective technology in a much smaller area as compared to conventional stone and pipe systems. The Mantis 430-10 measures 12" tall x 30" wide x 5' long and weighs only 15 pounds. Each unit is comprised of 10 individual geotextile covered modules that provide for oxygen transfer within the system and storage of effluent during peak flow periods. Its unique design offers both 6" and 12" inverts in the same unit and has been approved with an effective leaching area credit by the DPH of 6.5sf/lf for systems using the 6" invert, and 11.0 sf/lf for systems using 12" inverts.

Installation is quick and easy. A typical three bedroom home can be installed in about three hours depending on site conditions. The system requires no stone for installation. Instead, the units are installed with a medium to coarse wash concrete sand that meets the ASTM C-33 specification with less than 10% passing a #100 sieve and less than 5% passing a #200 sieve. The units are placed on 6" minimum of the specified sand with additional specified sand placed between the geotextile modules and along the sides of the units. Excess sand can be spread over top of the system and backfilled using native materials to finish grade. This technology is installed in trench configurations and can distribute effluent utilizing gravity; pressure dosed or pressure distribution applications. Septic contractors can purchase the Mantis 430-10 direct from the factory at the company's East Hartford, CT manufacturing facility. Elien will be conducting training seminars on the Mantis Geotextile Sand Filter throughout the state in the coming months.
