COWRA held its 2009 Installer course in January and February of this year. COWRA's 2009 Installer course did not escape the affects of this difficult economy. Enrolment in our 2007 Installer School was 68 students. In 2008 our Installer School had 83 students. This year enrollment was down to 37 Students.

This however, only served to enhance the teacher / student interaction. Once again Briggs Geddis and Doug DiVesta did an incredible job teaching our students the skills and knowledge, they will need to prepare for the 2009 State Licensing Exam.

This year, because of the new Technical Standard Revisions our school was attended by a few veterans of the wastewater industry. These included John Fay and Leo Tetreault of Honey Wagon Septic Tank Services out of Manchester CT and Arthur Ruff of Art's Septic Tank Service in Glastonbury CT.

All three men have been the Septic business for many, years. These three veterans of the industry took the course because of the new Public Health Code Revisions. All three felt their time

was well spent by taking the course and felt they had learned valuable information.

Other students included a few who had lost jobs in other industries because of our unsettled economy. These students were seeking new avenues of employment.

For five consecutive Thursdays, students sat through 3 hours of class dedicated to the teaching of the information and skills each student will need to obtain their license for septic installation.

that these two men spend in preparation for this class.

Chatham Health District Wastewater Pumping and Permit to Discharge Regulations

The Chatham Health District which governs the towns of East Haddam, East Hampton, Haddam, Hebron, Marlborough and Portland will be implementing new Wastewater Pumping and Permit to Discharge Regulations in April 2009.

These regulations will significantly impact the procedures of pumping and cleaning septic systems in the Chatham Health District.

These regulations are the wave of the future. This type of regulation will be going into effect in all Health Districts throughout Connecticut within the next few years. Currently, Newtown, Guilford, Westbrook and Essex have this type of regulation in effect in their districts. Newtown and Guilford have had these regulations in effect for many years. Westbrook began in 2006 and Essex began in January 2009.

The Connecticut Department of Public Health is currently reviewing the town of Ledge Light Health Districts and the Chatham Health Districts, Permit to Discharge Regulations. Ledge Light Health District includes the Town of East Lyme, Town and City of Groton, the Town of Ledyard, the City of New London and the Town Waterford.

Thad King and Don Mitchell of the Chatham Health District have been working with licensed Pumper/Cleaners who work within their District. They have welcomed comments and suggestions from our industry, as they have worked through the process of preparing these regulations. April 20, 2009 the Chatham Health District will meet Cleaners registered with their district, to further discuss these regulations. Thad King and Don Mitchell are both members of Connecticut Onsite Wastewater Recycling Association. A copy the Chatham Health District's Permit to Discharge Regulations is in this newsletter as an insert.
